

DRIFTWOOD SHED TERMS AND CONDITIONS 2023

By paying your deposit you are agreeing to our Terms and Conditions.
Failing to adhere to any of them will result in the total loss of your bond.

HIRE PERIOD-

- Is from Friday midday till Sunday midday.
- Only one function may be held in that timeframe unless otherwise arranged with us.
- Functions may start anytime on the Saturday, but must finish at 11pm.
- All guests must be off the property by midnight.
- If you have a bus for your guests, they should be here to pick up guests by 11.00pm, ready to leave by 11.30pm.

MAXIMUM GUESTS- up to 100

BOOKING POLICIES-

- a \$1000 Booking Deposit is required to secure your date. This will also act as a Security Bond, which will be returned upon positive inspection.
- Payment in full is required 6 weeks before your function.

CANCELATION POLICY-

- Booking deposit is non-refundable if cancelled by client.
- 50% of any payments made toward the tariff will be refunded.

CONDITIONS-

- We have a "leave it how you found it" Policy. Premises and grounds to be left clean and tidy, and on time.
- The hirer is responsible for their guests and liable for their guests actions, including coming and going in a quiet manner.

DRIFTWOOD CABIN-

- The Driftwood Cabin can accommodate up to 6 guests. We provide bed linen, but please bring your own towels.

NOISE RESTRICTIONS-

- Live music, such as a guitarist or duo, are permitted in the afternoon for the ceremony, cocktail hour and during dinner.
- For dance-time in the shed, our in-house sound system must be used. You can either do your own playlist, or if you want to use a DJ, they are to plug their gear into our speakers.
- All music to cease at 11pm.

SERVICE OF ALCOHOL-

- Alcohol is BYO, however we provide bar staff for the duration of your function. We just ask that you provide a meal for them in your catering
- Bar closes at strictly 10:45pm.

INSURANCE-

- Our Public Liability covers you and your guests.
- Please ask any external contractors (caterers etc.) to provide a Certificate of Currency showing inception, Expiry, Value.

LOSS/THEFT/DAMAGE-

- We take no responsibility for the hirers or guests personal property.

RUBBISH-

- We provide 2 x large Sulo bins for your use. Any excess must be removed by the hirer.
- Please separate cardboard and glass for recycling.
- Please keep plastic bottled water to a minimum. We provide water stations and glass water bottles for the dining tables.

CATERERS KITCHEN-

- Must be left clean including mopping of floors, cleaning oven, stovetop etc. or a \$500 cleaning fee will be charged.

CROCKERY/GLASSWARE-

- Is provided by us. We wash all glasses and caterers are required to wash all plates and cutlery.

- STRICTLY NO FIREWORKS- due to neighbouring livestock.

PARKING-

- Please drive on designated driveways to keep the grounds nice for other clients.
- Do not drive on soccer field or lawns.
